GREENE COUNTY AUDITOR'S OFFICE 2019 DOG LICENSE APPLICATION FORM

Ohio law requires that all dog licenses be purchased prior to January 31, in order to avoid a penalty. The two exceptions for this rule are:

- You have 30 days from the date you acquired the dog to obtain a license without penalty
- A dog is not required to be licensed until it is 3 months old

Ohio law requires that the penalty be equal to the cost of the license.

LICENSE FEES EXPLANATION

Dog licenses purchased prior to January 31st are never subject to a penalty and cost \$20

Dog licenses purchased after January 31st are subject to a \$20 penalty unless:

- The dog was acquired or brought from out of state within 30 days of the license being purchased or
- o The dog is less than three months old at the time the license is purchased

PARTIAL YEAR LICENSE

If you are purchasing a license after June 30th and the dog was not required to be licensed prior to June 30th you can purchase a partial year license. A license purchased after June 30th only costs \$10 if:

- The dog was acquired or brought from out of state within 30 days of June 30th or
- The dog is less than three months old on June 30th.

A partial year license is subject to a \$10 penalty if:

- o The tag was purchased after June 30th; and
- o The license was not purchased within 30 days of the dog being acquired or brought from out of state; or
- The dog is older than 3 months when the license was purchased.

MULTI YEAR LICENSE

Ohio law now allows a license to be purchased for multiple years. There is no price break for purchasing a multiyear license and no refunds are given if you no longer have the dog or move out of state. Licenses can be purchased for three (3) years for \$60 or a permanent license can be purchased for \$200.

KENNEL FEES

In order to obtain a kennel license, you must be in the business of buying and selling dogs and you must be zoned for a kennel.

- o The cost of a kennel license is \$100. That includes 5 kennel tags. Additional kennel tags are available for \$1 each.
- Any kennel license purchased after January 31st is subject to a \$100 penalty and each additional license purchased is subject to a \$1 penalty.

GENERAL INFORMATION

- The license is valid anywhere in Ohio from the date purchased to January 31st of the succeeding year.
- If information changes please contact the Auditor's office so that we can update your records.
- Dog registration information is contained in Section 955 of the Ohio Revised Code.
- Revenue generated from the sale of dog licenses go to support the Greene County Animal Shelter with a maximum of 15% of the revenue going for the administration of licensing program.
